1. ABOUT VILAF

2. VILAF TRAINING CLASS

- 1. What for? Developing skills for negotiating and drafting commercial contracts;
- 2. Who can take part? Last year students with GPA of 7.0 and above, good English skills;
- 3. **Who are lecturers and tutors?** Senior lawyers of VILAF who will give lectures, guidance and support throughout the course;
- 4. **How long?** Two days: morning and afternoon;
- 5. When? October, on annual basis;
- 6. **Training methodology?** Lectures followed by group exercises with real cases;
- 7. **How to know about the class?** Information is made via the Youth Union and University websites;

- Shortlisted students are invited to group interview/job orientation conducted by most experienced lawyers of VILAF

3. INTERNSHP PROGRAM

9. What for?

- To understand how laws are practiced in the real world;
- o To understand about working as professional lawyer in a law firm;
- To test your suitability to be professional lawyer;
- 10. **How long?** Four months from January to April, on annual basis. You work full time from Monday to Friday and attend legal trainings on Saturday.
- **11. What do you do as Intern?** Working in legal teams of Corporate, M&A, Capital Market, Banking, Finance, Litigation, Dispute Resolution. You will be supervised and guided by senior lawyers. Your tasks mainly include researching for various issues, sometimes you can also be involved in drafting memo and/or contract.

12. How to apply?

- Sending resume and motivation letter (in English);
- Shortlisted students are invited to interview;
- 6 8 students are selected for the Internship;

13. **Others:**

- Internship allowance is provided;
- Feedbacks about your works, your strengths and weaknesses are provided from time to time, in particular at the closing review;

- Opportunities for working as VILAF Trainee Lawyers;
- VILAF Internship should give you good working experience and skills good preparation for your career plan;
